

MY Guitar Idolz

TERMS AND CONDITIONS

A. <u>The Event / Eligibility</u>

- 1. "MY Guitar Idolz" ("the Contest") is organised by Yamaha Music (Malaysia) Sdn Bhd ("the Organiser").
- 2. The Contest is open to all individual legal residents of Malaysia with a valid identification document, aged 6 years and above at the start of the Contest period ("the Participants"). The Organiser shall reserve the right to request evidence of identification documents. The following groups of persons shall not be eligible to participate in the Contest:
 - a. Employees of the Organiser and its group of companies and their immediate family members (spouse, children, parents, siblings, and their spouses); and
 - b. Employees of the Organiser's agencies associated with the contest and their immediate families (spouse, children, parents, siblings, and their spouses).
- 3. Participants below the age of 18 must have the consent of the parent or guardian before participating in this contest.
- 4. The Contest will run from 0:00:00am on 01 October 2023 to 23:59:59pm on 30 October 2023 ("Contest Period").
- 5. Participants must follow the steps of the Contest provided in the column below.

- 7. The post must be set to "Public" to be eligible for judging criteria.
- 8. The video must be original, creative, and not exceed 60 seconds in length.
- 9. Only **one entry** per participant is allowed.

C. <u>How to participate</u>

- 1. Record and create a video of your Guitar performance using a Yamaha Guitar.
 - i. Recorded video must have a clear visual of Yamaha Guitar.
 - ii. Music composition or arrangement must be played solo/individually. Video of ensembles will be disqualified from participating in this contest.

- 3. Adjust your audience settings and set your post to "Public".

- 2. The winner will be announced on our social media channels by **6th November 2023.**
- 3. Winner will be notified via direct message.
- 4. The decision of the judges is final, and no correspondence will be entertained.
- 5. The Organiser reserves the right at its absolute discretion to substitute the prize with alternative prize or prize at any time without prior notice. Prize is not transferable or exchangeable for other products or for cash.
- 6. Acceptance of the prize shall constitute consent on the part of the winner to allow the use of the winner's name, personal data, photo, contents, image, voice by the Organiser for editorial, advertising, promotional, marketing and/or other purpose without further compensation.
- 7. Winner to self-collect the prize at **Yamaha Music Kelana Jaya** at their own expense. The Organiser shall not be held responsible for any negligence on the part of the Participants and or misinformation provided to the Organiser in claiming the Prize.
