SOFTWARE LICENCING AGREEMENT

About RIVAGE PM Editor

RIVAGE PM Editor (hereinafter referred to as "PM Editor") is a software program that allows you to preconfigure the RIVAGE PM system on your computer (offline editing) and to monitor or operate the RIVAGE PM system (online monitoring/operation).

Connecting the RIVAGE series control surface and a computer with PM Editor to the RIVAGE PM system simultaneously allows you to control the system from both units. Even if you cannot continue to control the system due to a problem with a control surface, you can still use PM Editor to control the mixing parameters in the RIVAGE PM system.

Precautions for Use

- For RIVAGE PM Editor earlier than V2.0.0, only one PM Editor can be used per system. RIVAGE PM Editor V2.0.0 or later allows use of up to two per system. Do not connect computers exceeding the usable number. When you are using two PM Editors for one system, connect the computers to each NETWORK connector of the DSP engine and the console surface or connect the computers via the switching hub.
- If you synchronize PM Editor with DSP-R10/CSD-R7, any "RECALL UNDO" that was enabled until that point is reset.

Step 2 Connection and Activation

Connect your computer to the RIVAGE PM system, and launch PM Editor. (Page 6)

RIVAGE PM Editor has the same functions as the touchscreen of the control surface.

Installing the PM Editor and making the network settings

Installing the PM Editor

Follow the instructions below to install the PM Editor. No additional software is needed to run the PM Editor.

1 Extract the downloaded file and double-click "setup.exe" (Windows) or "Yamaha RIVAGE PM Editor Vx.x.x.pkg" (Mac).

The setup dialog of the PM Editor is displayed.

NOTE • x.x.x represents the firmware version number.

- Click [Continue] or [Yes], if the "User Account Control" window appears.
- 2 Follow the on-screen instructions and install the software.

Network Settings

Make the following network settings when connecting a computer with the PM Editor installed to the RIVAGE PM system.

TCP/IP settings of the computer

IP address	192.168.53.1 – 192.168.53.32
Subnet mask	255.255.255.0

Making TCP/IP settings for the computer

■ Windows

1 Access the Control Panel, then click or double-click [Network and Sharing Center] or [View network status and tasks].

The "Network and Sharing Center" window is called up.

2 Click [Manage network connection] or [Change adapter settings] from the "Tasks" list located in the left side of "Network and Sharing Center" window, then double-click [Local Area Connection].

(Select [Local Area Connection 2] etc., depending on your environment.)

The "Local Area Connection Status" dialog box is called up.

If the "Local Area Connection properties" dialog box appears instead, skip ahead to step 4.

3 Click [Properties].

The "Local Area Connection properties" dialog box is called up.

4 Select [Internet Protocol Version 4 (TCP/IPv4)], then click [Properties].

The "Internet Protocol Version 4 (TCP/IPv4) Protocol" dialog box is called up.

- 5 Click [Use the following IP address].
- 6 Enter your computer's IP address into [IP address] and the Subnet mask into [Subnet mask].
- 7 Click [OK].

NOTE The "User Account Control" dialog box may appear during the procedure. If so, click [Continue].

- Mac
- 1 Click [System Preferences], then click [Network].

The "Network" dialog box will be displayed.


2 Click the service that you want to connect to the device.

If you're using the Ethernet port that's built into the Mac, click [Ethernet].

- 3 In "Configure IPv4," choose [Manually].
- 4 Enter your computer's IP address into [IP address] and the Subnet mask into [Subnet Mask].
- 5 Click [Apply] button, then close "Network" dialog box.

Connection and Activation

1 Use an Ethernet cable to connect the computer with PM Editor to the RIVAGE PM system.



Connect the computer where PM Editor is installed to the DSP engine. To establish a connection with the DSP engine, connect the cable to the NETWORK terminal (PC) located next to the TO CONSOLE terminal. Never connect the cable to the NETWORK terminal above the HY card slots.

Alternatively, you can connect the cable to the NETWORK terminal on the control surface. Note that in the RIVAGE PM10 system, connection with the DSP engine will be cut off and the communication cannot be established if you turn off the power to the control surface.

NOTE • For RIVAGE PM Editor earlier than V2.0.0, only one PM Editor can be used per system. RIVAGE PM Editor V2.0.0 or later allows use of up to two per system. Do not connect computers exceeding the usable number.

• When you are using two PM Editors for one system, connect the computers to each NETWORK connector of the DSP engine and the console surface or connect the computers via the switching hub.

2 Activate PM Editor.

In Windows 7: "Start" → "All Programs" → "RIVAGE PM Editor"


In Windows 8.1/Windows 10: Click the "RIVAGE PM Editor" tile on the "Start" screen

In Mac: Open the "Applications," and then double-click "RIVAGE PM Editor"

NOTE If the "User Account Control" dialog box appears, click [Yes].

After you activate the software, a popup window for establishing a connection appears.

Select "MIXER TYPE," and then click the [Connect] button to start PM Editor.

Uninstalling the Software (Deleting the Application)

■ Windows

Use the "Control Panel" to uninstall RIVAGE PM Editor.

Go to "Control Panel" → "Programs and Features" or "Uninstall a program," select the items you wish to delete, and click [Uninstall]. Next, a dialog box appears. Follow the instructions on the screen to delete the application. If the "User Account Control" window appears, click [Continue] or [Yes].

■ Mac

Double-click "Uninstall RIVAGE PM Editor.app" which is included in the installer. Follow the instructions on the screen to delete the application.

Troubleshooting

Cannot synchronize the PM Editor with the RIVAGE PM system.

• Is the network cable properly connected?

Is there any resident security software installed?

If the firewall function of anti-virus or security software is enabled, the communication may not be established properly.

• Are the network settings configured correctly?

• Is the selected MIXER TYPE correct?
